

SLAVERY AND HUMAN TRAFFICKING STATEMENT

INTRODUCTION

Modern slavery is a crime and a gross violation of fundamental human rights. It takes various forms, all of which have in common the deprivation of one person's liberty by another to exploit them for personal or commercial gain. Slavery and human trafficking remain a hidden blight on our global society. We all have a responsibly to be alert to the risks, however small, in our business. Staff are expected to report concerns and management are expected to act upon them.

We have a zero-tolerance approach to modern slavery and are fully committed to preventing slavery and human trafficking in our corporate activities. We are also committed to ensuring there is transparency in our own business and in our approach to tackling modern slavery throughout our supply chains, consistent with our disclosure obligations under the Modern Slavery Act 2015 updated 2018. We all have a responsibly to be alert to the risks, however small, in our business and in the wider supply chain.

ORGANISATION'S STRUCTURE

Standguide Group is a private company. The company key business functions are based at Standguide's Head Office in Stretford, Manchester. These act as a central nucleus and are the main support network for centres nationally.

- Monitor potential risk areas in our supply chains.
- We have in place systems to encourage the reporting of concerns and the protection of whistle blowers.
